# Foreword

Since 1997, the Texas Legislative Council publication *Summary of Enactments* has included a table to indicate statutory state agencies, interagency panels, advisory committees, and other state government entities that were created, restructured, or eliminated by the legislature. *New, Renamed, and Abolished State Government Entities* replaces the table with an expanded format that provides more information about the affected entities.

The New Entities section provides information on each new entity that has been created. Some of these new entities are tied to the abolishment of another entity, but are not considered a renaming or replacement of that entity because they have different functions and composition. An example is the Advisory Board on Barbering, which was created as part of the discontinuation of the State Board of Barber Examiners and transfer of its regulatory functions to the Texas Department of Licensing and Regulation. The State Board of Barber Examiners is included in the section for abolished entities with a reference to the new entity.

The Renamed Entities section provides information on each entity that received a name change but retained substantially the same functions and composition.

The Abolished Entities section provides information on each entity that was abolished or discontinued because the statute creating it was repealed. If functions of the entity were transferred substantially unchanged to an already existing entity, that is noted. If functions were substantially revised and assigned to a new entity described in the New Entities section, that is noted.

For each entity included in the publication, the following information is provided:

**Name**—The name of the entity in the legislation. If the entity advises or is administratively attached to an agency, that agency's name appears in parentheses. For an entity that has been renamed, the previous name is indicated. For an abolished entity, if its functions are transferred, the entity that assumes those functions is also named.

**Legislation**—The bill and specific bill sections that contain provisions creating, renaming, or abolishing the entity and that contain other information, such as functions and composition. In some cases the entire bill is about the entity. The date the creation, renaming, or abolition of the entity becomes effective is provided. If creation of the entity is authorized instead of mandated, that is noted.

**Functions**—Powers and duties of the entity. For entities that have been renamed, if the functions have been revised, the functions under both the previous name and the new name are included. Information about the transfer of functions to another entity is included if applicable.

**Composition**—Membership information for the entity, including the number of members, eligibility criteria, and the selection process. If the composition of a renamed entity has been changed, the composition of the entity under both the previous name and the new name is included.

**Expiration Date**—The sunset date or other expiration date included in the legislation or in the entity's statutory authorization. If the entry is "None," it means that the entity has no express statutory date to expire.





## New Entities

### Arthritis Advisory Committee (Department of State Health Services)

**Legislation:** Senate Bill 691, Section 1; creation is effective September 1, 2005

**Function:** Advises the Department of State Health Services on developing and implementing the arthritis control and prevention program

**Composition (unspecified number of members):**

- Persons with arthritis
- Public health educators or other persons knowledgeable in health education
- Medical experts on arthritis
- Providers of arthritis health care
- Representatives of national arthritis organizations and their local chapters

*All members are appointed by the commissioner of state health services.*

**Expiration date:** None

### Availability of Pre-Owned Heavy Duty Commercial Motor Vehicles, Study Commission on

**Legislation:** House Bill 2702, Section 3.04; creation is effective June 14, 2005

**Functions:**

- Conducts public hearings and studies public policy implications relating to any act by the Texas Department of Transportation that would close existing businesses in Texas because of the ownership structure of businesses that sell pre-owned heavy duty trucks that weigh in excess of 11,000 pounds, to include the following:
  - A review of the laws of other states regarding whether there are restrictions on ownership structure of businesses that sell heavy duty commercial trucks
  - A review of whether safety of pre-owned heavy duty trucks on Texas highways could be compromised if the Texas Department of Transportation closes businesses that currently sell such trucks
  - A review of whether the Texas Department of Transportation's application of Section 2301.476, Occupations Code, could negatively impact competition in the pre-owned heavy duty truck market as well as the impact that such a decision could have on small, independent pre-owned truck dealerships and independent owner/operators of trucking businesses in Texas
  - Other issues that the commission considers relevant to protecting the public interest regarding safety and availability of pre-owned heavy duty trucks that operate on Texas highways

- Reports to the governor, lieutenant governor, speaker of the house, and chairs of house and senate committees with jurisdiction of transportation issues not later than December 1, 2006

**Composition (3 members total):**

- 1 member appointed by the governor
- 1 member appointed by the lieutenant governor
- 1 member appointed by the speaker of the house

**Expiration date:** None stated, but the nature of the charge implies the committee's termination on submission of its report

**Barbering, Advisory Board on (Texas Department of Licensing and Regulation)**

**Legislation:** Senate Bill 411, Sections 2.03–2.07, 5.01, 6.01; creation is effective September 1, 2005; the State Board of Barber Examiners is continued in existence until January 1, 2006, for the sole purpose of transferring obligations, and its regulatory functions are transferred to the Texas Department of Licensing and Regulation

**Functions:**

- Advises the Texas Commission of Licensing and Regulation and the Texas Department of Licensing and Regulation on education and curricula for applicants, the content of examinations, proposed rules and standards on technical issues related to barbering, and other issues affecting barbering
- Responds to questions from the department and the commission regarding barbering

**Composition (5 members total):**

- 2 members, each of whom is engaged in the practice of barbering as a Class A barber and does not hold a barbershop permit
- 2 members, each of whom is a barbershop owner who holds a barbershop permit
- 1 member who holds a permit to conduct or operate a barber school

*All members are appointed by the presiding officer of the Texas Commission of Licensing and Regulation with the commission's approval.*

**Expiration date:** None (removed from the Texas Sunset Act)

**Bicycle Advisory Committee (Texas Department of Transportation)**

**Legislation:** Senate Bill 602, Section 1; creation is effective September 1, 2005

**Function:** Advises the Texas Transportation Commission on the development of bicycle tourism trails in Texas

**Composition:** To be determined by the Texas Department of Transportation

**Expiration date:** None

## **Binational Alcohol and Substance Abuse Task Force**

**Legislation:** House Bill 3426, Section 1; creation is effective September 1, 2005

### **Functions:**

- Studies the following:
  - Effect of substance abuse on residents living near the border, with emphasis on residents who are at least 14 years of age but younger than 26 years of age
  - Hereditary factors that may contribute to a predisposition to alcohol dependency
  - Contributing factors of binge drinking by both minors and persons of legal drinking age and the effects on health and the community of binge drinking
  - Effect on the community of drug traffickers using young residents living near the border to transport illegal drugs into the United States
- Reports to the governor and the legislature not later than November 1 of each even-numbered year

### **Composition (27 members total):**

- 12 statutory members:
  - 5 members of the house, each of whom represents a district wholly or partly located 25 miles or less from the international border, appointed by the speaker of the house
  - 5 members of the senate, each of whom represents a district wholly or partly located 25 miles or less from the international border, appointed by the lieutenant governor
  - The commissioner of the Department of State Health Services or the commissioner's designee
  - The director of the Department of Public Safety or the director's designee
- 15 members nominated by the task force chair and vice chair and appointed if a majority of the other members of the task force approve their appointment:
  - 3 district attorneys or their representatives from different locations along the international border
  - 3 representatives of the public from different locations along the international border who have significant experience working in substance abuse and intervention programs in a border county
  - 3 representatives employed by a local law enforcement agency that has jurisdiction extending to the international border
  - 3 licensed physicians from different locations along the border
  - 1 member from each of the following organizations: the State Bar of Texas; the Mexican American Bar Association; a nonprofit organization with significant experience in issues prevalent in the border region

*In addition, the task force may invite the following to participate as members of the task force in task force activities:*

- *Individuals from any state in the United Mexican States that borders Texas who have qualifications similar to those of members of the task force*
- *Federal agencies with jurisdiction over alcohol and illegal drug laws*

**Expiration date:** January 1, 2009

## **Border Inspection, Trade, and Transportation Advisory Committee** (Office of the Secretary of State)

**Legislation:** House Bill 925, Section 3; creation is effective September 1, 2005

**Function:** Identifies problems involved with border truck inspections and related trade and transportation infrastructure and develops recommendations for addressing those problems

**Composition (unspecified number of members):**

- Texas Department of Transportation
- Department of Public Safety
- Office of State-Federal Relations
- U.S. Department of Transportation
- Federal Motor Carrier Safety Administration
- Other state and federal agencies involved in border crossing issues

*All members are appointed by the border commerce coordinator in the Office of the Secretary of State.*

**Expiration date:** None

## **Border Issues, Interagency Work Group on**

**Legislation:** House Bill 925, Section 4; creation is effective September 1, 2005

**Functions:**

- Develops or updates a process to allow agencies to work together on issues that face border communities
- Discusses and coordinates programs and services offered to border communities and residents of border communities
- Develops regulatory and legislative recommendations to eliminate duplication and combine program services

**Composition (17 members total):** To include the heads of the following state agencies or their designees:

- Office of Rural Community Affairs

- Texas Department of Housing and Community Affairs
- Texas Water Development Board
- Texas Department of Transportation
- Texas Commission on Environmental Quality
- Texas Workforce Commission
- Department of State Health Services
- Health and Human Services Commission
- General Land Office
- Texas Education Agency
- Texas Economic Development and Tourism Office
- Texas Office of State-Federal Relations
- Texas Higher Education Coordinating Board
- Office of the Attorney General
- Office of the Secretary of State
- Department of Public Safety
- Railroad Commission of Texas

**Expiration date:** None

## **Building Healthy Families, Interagency Coordinating Council for**

**Legislation:** House Bill 1685, Section 1; creation is effective June 17, 2005

### **Functions:**

- Facilitates communication and collaboration among state agencies involved with the prevention of and early intervention in child abuse and neglect
- Submits to the lieutenant governor, speaker of the house, and legislature an inventory of the child abuse and neglect prevention and early intervention policies, programs, and activities of each agency represented on the council
- Reports to the lieutenant governor, speaker of the house, and legislature not later than December 1, 2006, on the council's recommendations for improving the coordination and collaboration of child abuse and neglect prevention and early intervention programs and services among state agencies and the council's recommendation regarding whether to continue the council

**Composition (10 members total):** To include one representative from each of the following state agencies:

- Department of Family and Protective Services
- Health and Human Services Commission

- Department of State Health Services
- Department of Aging and Disability Services
- Texas Youth Commission
- Texas Education Agency
- Texas Workforce Commission
- Office of the Attorney General
- Texas Juvenile Probation Commission
- Texas Department of Housing and Community Affairs

*Members are appointed by the executive director or commissioner of the respective agency.*

**Expiration date:** September 1, 2007

### **Colonia Residents Assistance, Supplemental Advisory Committee on (Office of the Secretary of State)**

**Legislation:** Senate Bill 1202, Section 2; creation is authorized, not mandated, effective June 17, 2005

**Function:** Supplements the efforts of the Colonia Resident Advisory Committee to improve services delivered to colonia residents

**Composition (unspecified number of members):** Representatives of colonia residents in counties that are not represented by a member of the Colonia Resident Advisory Committee, appointed by the border initiatives coordinator in the Office of the Secretary of State

**Expiration date:** None

### **Community Outreach Committee, Advisory Oversight (Department of Public Safety)**

**Legislation:** House Bill 925, Section 1; creation is effective September 1, 2005

**Functions:**

- Documents trade-related incidents involving Department of Public Safety (DPS) personnel
- Develops recommendations and strategies to improve community relations, DPS personnel conduct, and the truck inspection process at Texas ports of entry
- Acts as ombudsman between the DPS and border residents and between the DPS and DPS personnel

**Composition (unspecified number of members):**

- Border crossing bridge owners
- Directors of entities governing ports of entry

- Community leaders
- Planning developers
- Mayors of border municipalities or their designees
- Representatives of law enforcement
- Representatives of the general public

*All members are appointed by the Public Safety Commission.*

**Expiration date:** None

## **Cosmetology, Advisory Board on** (Texas Department of Licensing and Regulation)

**Legislation:** Senate Bill 411, Sections 3.03–3.09; 5.01, 6.01; creation is effective September 1, 2005; the Texas Cosmetology Commission is continued in existence until January 1, 2006, for the sole purpose of transferring obligations, and its regulatory functions are transferred to the Texas Department of Licensing and Regulation

### **Functions:**

- Advises the Texas Commission of Licensing and Regulation and the Texas Department of Licensing and Regulation on education and curricula for applicants, the content of examinations, proposed rules and standards on technical issues related to cosmetology, and other issues affecting cosmetology
- Responds to questions from the department and the commission regarding cosmetology

### **Composition (5 members total):**

- 1 member who holds a license for a beauty shop that is part of a chain of beauty shops
- 1 member who holds a license for a beauty shop that is not part of a chain of beauty shops
- 1 member who holds a private beauty culture school license
- 2 members who each hold an operator license
- The associate commissioner for occupational education and technology at the Texas Education Agency or that person's designee (ex officio member without voting privileges)

*All members are appointed by the presiding officer of the Texas Commission of Licensing and Regulation with the commission's approval.*

**Expiration date:** None (removed from the Texas Sunset Act)

## **Emerging Technology Committee, Texas**

**Legislation:** House Bill 1765, Section 1; creation is effective June 14, 2005

**Function:** Makes recommendations to the governor, lieutenant governor, and speaker of the house for awarding money from the Texas emerging technology fund

**Composition (17 members total):**

- Industry leaders in Texas
- Nationally recognized researchers from public or private Texas institutions of higher education

*All members are appointed by the governor from nominations that may be submitted by the Texas Higher Education Coordinating Board; a president of a public or private institution of higher education in Texas; the members of the Texas Workforce Commission; a representative of the governor's office involved in economic development activities; a representative of the lieutenant governor's office involved in economic development activities; a representative of the office of the speaker of the house involved in economic development activities; and other persons considered appropriate by the governor.*

**Expiration date:** None

## **Eminent Domain, Interim Committee on the Power of (Texas Legislature)**

**Legislation:** Senate Bill 7, 2nd C.S., Section 8; creation is effective November 18, 2005

**Functions:**

- Studies the use of the power of eminent domain, including the use of the power of eminent domain for economic development purposes and the issue of what constitutes adequate compensation for property taken through the use of eminent domain
- Reports to the lieutenant governor and speaker of the house not later than December 1, 2006

**Composition (10 members total):**

- 5 members of the senate appointed by the lieutenant governor
- 5 members of the house of representatives appointed by the speaker of the house

**Expiration date:** None stated, but the nature of the charge implies the committee's termination on submission of its report

## **Entrepreneurship Network, Advisory Board on Operations of the Texas (Texas Entrepreneurship Network)**

**Legislation:** House Bill 1747, Section 1; creation is effective September 1, 2005

**Function:** Guides and advises the operations of the Texas Entrepreneurship Network (see next entry)



**Composition (unspecified number of members):**

- 1 representative from each of the founding members of the Texas Entrepreneurship Network
- At least 1 member from the private sector

*An organization other than a founding member of the network may have a representative on the board only if an additional seat on the board is authorized by a two-thirds majority vote of the existing board.*

**Expiration date:** None

## **Entrepreneurship Network, Texas**

**Legislation:** House Bill 1747, Section 1; creation is effective September 1, 2005

**Functions:**

- Trains and refocuses existing state and local resources to build a more prosperous, dynamic, and sustainable economy throughout Texas by:
  - Providing coordinated training and services that enhance the value of the state's existing infrastructure investments and make the investments available to entrepreneur participants
  - Developing a statewide network of entrepreneurship developers and entrepreneurship centers
  - Developing a comprehensive network of knowledge, leadership, and financial capital resources accessible through the network's entrepreneurship developers and entrepreneurship centers
  - Educating entrepreneur participants and generating awareness of the network and its programs
  - Identifying the most promising ventures through activities, including business-plan competitions, and assisting the ventures' potential for job and wealth creation
  - Developing evaluation methods to measure the effectiveness of the network and the impact of entrepreneurship on local and regional economies
  - Developing best practices for successful entrepreneurship and applied research regarding critical success factors for entrepreneurial businesses
  - Collaborating with existing local, state, and federal agencies and economic development professionals
- Works locally, regionally, and statewide with educators, agencies, organizations, networks, businesses, economic developers, consultants, communities, researchers, or other persons to develop and support strategies to assist entrepreneur participants and improve the environment for entrepreneurial development in Texas

**Composition (unspecified number of member entities):**

- Founding members of the network:

- College of Agricultural Sciences and Natural Resources at Texas Tech University
- Department of Agriculture

**Expiration date:** None

### **(Facility Residents' Behavior) Best Practices Work Group (Health and Human Services Commission)**

**Legislation:** Senate Bill 325, Section 8; creation is effective September 1, 2005

**Functions:** Studies and makes recommendations regarding the following:

- Development of a comprehensive reporting system
- Prevention of the death of or serious injury to facility residents related to physical intervention or restraint
- De-escalation techniques and minimum standards to manage the behavior of facility residents in an emergency situation
- Best practices for physical, behavioral, and de-escalation interventions by employees that include specific holds and techniques for the physical restraint of facility residents
- Best practices related to specific populations, including any consideration that should be given to a facility's community or institutional setting
- Best practices related to seclusion of facility residents

**Composition (unspecified number of members to be determined by the executive commissioner of the Health and Human Services Commission):**

- Representatives of the following agencies:
  - Department of State Health Services

- Department of Aging and Disability Services
- Department of Family and Protective Services
- Texas Youth Commission
- Texas Education Agency
- Texas Juvenile Probation Commission
- A representative of Texas' protection and advocacy system established as required by 42 U.S.C. Section 15043 who is appointed by the administrative head of that system

- 3 members who are Department of State Health Services employees representing the department in epidemiology and the licensing of hospitals or ambulatory surgical centers and serve as nonvoting members of the advisory panel

  - The state regulatory reporting mechanisms relating to the appropriateness and effectiveness of medical peer review in hospitals and other health care entities and the oversight and authority of the state to ensure good faith medical peer review in hospitals and other health care entities in Texas



- The potentially negative impact on medical peer review in Texas that could result from potential changes to immunity protections or the oversight and investigation of physician claims of misuse of the medical peer review process

## **Perfusionist Advisory Committee, Texas State (Department of State Health Services)**

**Function:** Advises the Department of State Health Services on issues relating to the regulation of perfusionists

### **Composition (5 members total):**

- 2 licensed perfusionists who have been licensed for at least three years
- 1 physician licensed by the Texas Medical Board who is certified by that board in cardiovascular surgery
- 2 members who represent the public

## **Private Sector Advisory Council (Office of the Governor)**

  - The development and coordination of a statewide critical infrastructure protection strategy

  - Specific priorities related to the governor's homeland security strategy that the council determines to be of significant importance to the statewide security of critical infrastructure

- Other matters related to the planning, development, coordination, and implementation of initiatives to promote the governor’s homeland security strategy

**Rainwater Harvesting Evaluation Committee (Texas Water Development Board)**

**Legislation:** House Bill 2430, Sections 1 and 4; creation is effective June 17, 2005

**Functions:**

- Studies the feasibility of using rainwater as a source of water supply and evaluates the potential for rainwater harvesting in Texas
- Recommends:
  - Minimum water quality guidelines and standards for potable and nonpotable indoor uses of rainwater
  - Treatment methods for potable and nonpotable indoor uses of rainwater
  - Ways, such as dual plumbing systems, to use rainwater harvesting systems in conjunction with existing municipal water systems for residential, industrial, community, or public water supplies

- Addresses, with respect to the study by the Texas Department of Housing and Community Affairs of mortgage foreclosure rates in Bexar, Cameron, Dallas, El Paso, Harris, and Travis Counties, the following topics:
  - Extent to which the terms of mortgages are related to the foreclosure rate and whether the terms could be offered in a manner to reduce the likelihood of foreclosures
  - Socioeconomic and geographic elements characterizing foreclosures

### **Rule Concerning Content of Individualized Education Program for Student with Pervasive Developmental Disorder, Study Committee on the (Texas Education Agency)**

**Legislation:** Senate Bill 882, Section 13; creation is effective September 1, 2005

**Functions:**

- Studies the rule (19 T.A.C. Section 89.1055(e)) concerning the content of an individualized education program for a student with autism or another pervasive developmental disorder
- Considers whether any other considerations, such as applied behavior analysis, communication training, or the use of inclusive settings, should be included in the rule
- Reports to the commissioner of education not later than July 1, 2006, on any necessary changes to the rule

**Composition (unspecified number of members determined by the Texas Education Agency):** Includes parents of students with autism or other pervasive developmental disorders, teachers, school administrators, and other interested persons

*School district employees or educational consultants or contractors who receive or are employed by entities that receive compensation from a school district may not constitute more than 50 percent of the committee.*

### **School Health Advisory Committee (Department of State Health Services)**

**Legislation:** Senate Bill 42, Section 9; creation is effective June 17, 2005

**Function:** Provides assistance to the State Health Services Council in establishing a leadership role for the Department of State Health Services in support for and delivery of coordinated school health programs and school health services

**Composition (unspecified number of members established by the Health and Human Services Commission at the Department of State Health Services):** To include at least:

- 1 representative from the Department of Agriculture, appointed by the commissioner of agriculture
- 1 representative from the Texas Education Agency, appointed by the commissioner of education

**Expiration date:** None

## **Self-Insurance Group Guaranty Fund Board, Texas**

**Legislation:** House Bill 1353, Section 1; creation is effective September 1, 2005

### **Functions:**

- Creates and maintains a trust fund for payment of the workers' compensation liabilities of a group that is certified to self-insure for workers' compensation insurance coverage but that has been declared insolvent
- Provides recommendations to the commissioner of insurance regarding rules or guidelines applicable to groups

## **Statewide Integrated Care Management Advisory Committee (Health and Human Services Commission)**

### **Legislation:**

- House Bill 1771, Section 1; creation is authorized, not mandated, effective June 18, 2005
- Senate Bill 1188, Section 20; creation is authorized, not mandated, effective September 1, 2005

**Function:** Assists the executive commissioner of the Health and Human Services Commission in the development and implementation of the integrated care management model of Medicaid managed care

**Composition:** To be determined by the executive commissioner of the Health and Human Services Commission

### **Stroke Committee (Advisory Council on Emergency Medical Services, Department of State Health Services)**

**Legislation:** Senate Bill 330, Section 3; creation is effective September 1, 2005

**Function:** Assists the Advisory Council on Emergency Medical Services, in collaboration with the Texas Council on Cardiovascular Disease and Stroke, in developing a statewide stroke emergency transport plan and stroke facility criteria incorporating specified plan contents

- A licensed physician appointed from a list of physicians eligible for accreditation in vascular neurology from the Accreditation Council for Graduate Medical Education, recommended by a statewide organization of neurologists
- A licensed interventional neuroradiologist appointed from a list of neuroradiologists recommended by a statewide organization of radiologists
- A neurosurgeon with stroke expertise
- A member of the Texas Council on Cardiovascular Disease and Stroke who has expertise in stroke care
- A licensed physician appointed from a list of physicians recommended by a statewide organization of emergency physicians
- A neuroscience registered nurse with stroke expertise
- A volunteer member of a nonprofit organization specializing in stroke treatment, prevention, and education

### **Telecommunications Competitiveness Legislative Oversight Committee (Texas Legislature)**

**Legislation:** Senate Bill 5, 2nd C.S., Sections 26 and 27; creation is effective September 7, 2005

**Functions:**

- Conducts joint public hearings with the Public Utility Commission of Texas at least annually regarding the introduction of full competition to telecommunications services in Texas
- Monitors the effectiveness of telecommunications deregulation, including the fairness of rates, the quality of service, and the effect of regulation on the normal forces of competition

## **Texas-Mexico Strategic Investment Commission**

**Legislation:** House Bill 925, Section 2; creation is effective September 1, 2005

**Functions:**

- Represents government agencies within the Texas-Mexico border region to help reduce regulations by improving communication and cooperation between federal, state, and local governments
- Examines trade issues between the United States and Mexico
- Studies the flow of commerce at ports of entry between Texas and Mexico, including the movement of commercial vehicles across the border, and establishes a plan to aid that commerce and improve the movement of those vehicles
- Works with federal officials to resolve transportation issues involving infrastructure, including roads and bridges, to allow for the efficient movement of goods and people across the border between Texas and Mexico
- Works with federal officials to create a unified federal agency process to streamline border crossing needs
- Identifies problems involved with border truck inspections and related trade and transportation infrastructure

- Works to increase funding for the North American Development Bank to assist in the financing of water and wastewater facilities
- Explores the sale of excess electric power from Texas to Mexico
- Identifies areas of environmental protection that need to be addressed cooperatively between Texas and the Mexican states
- Identifies common challenges to health care on which all states can collaborate
- Develops recommendations, when possible, for addressing border challenges

- The border commerce coordinator in the Office of the Secretary of State, or a designee
- The executive director of the Texas Department of Transportation or a designee
- The executive administrator of the Texas Water Development Board or a designee
- The commissioner of state health services or a designee

- The executive director of the Texas Commission on Environmental Quality or a designee

## **Transportation Financing, Study Commission on**

**Legislation:** Senate Bill 1713, Section 1; creation is effective June 17, 2005

**Functions:**

- Conducts public hearings and studies public policy implications relating to the financing of transportation projects, including:
  - A review of the state motor fuels tax, including its efficacy in funding the transportation needs of Texas and an evaluation of the expenditure of funds from the state highway fund
  - A review of the current sources for funding rail transportation projects, including the options for rail funding and other possible sources of funding
  - A review of all other financing options for all modes of transportation, including but not limited to motor vehicle user fees and fines, bonding, and other debt financing methods

- A commissioner and an employee of each agency
- Representatives from other agencies that the veterans commission and workforce commission determine are necessary to accomplish the transition

**Legislation:** Senate Bill 990, Section 1; creation is effective September 1, 2005

**Function:** Advises the Department of State Health Services and the executive commissioner of the Health and Human Services Commission in the development of criteria and guidelines for the training and examination program on sexual abuse and child molestation for certain persons who work at youth camps

**Composition (not more than 9 members total):**

- At least 2 members who represent the general public
- Other members, who include experienced camping professionals representing Texas camping communities, representatives of youth camps selected by the Department of State Health Services, and representatives of the Council on Sex Offender Treatment

### Autism and Pervasive Developmental Disorders, Texas Council on

**Previous Name:** Interagency Council on Autism and Pervasive Developmental Disorders

**Functions** (unchanged except to emphasize input from people with autism and other pervasive developmental disorders, their families, and related advocacy organizations, and to add an annual report requirement):

- Provides recommendations to the Health and Human Services Commission and other appropriate state agencies responsible for implementing Chapter 114, Human Resources Code, including recommendations relating to the use of funds appropriated to the commission or another health and human services agency to provide services to persons with autism or other pervasive developmental disorders
- Addresses, with the advice of the advisory task force established in Section 114.005, Human Resources Code, and input from people with autism and other pervasive developmental disorders, their families, and related advocacy organizations, contemporary issues affecting services available to persons with autism or other pervasive developmental disorders in Texas, including:
  - Successful intervention and treatment strategies, including transitioning
  - Personnel preparation and continuing education
  - Referral, screening, and evaluation services
  - Day-care, respite care, or residential care services
  - Vocational and adult training programs
  - Public awareness strategies
  - Contemporary research
  - Early identification strategies
  - Family counseling and case management
  - Recommendations for monitoring autism service programs
- Advises the legislature, with the advice of the advisory task force and input from people with autism and other pervasive developmental disorders, their families, and related advocacy organizations, on legislation that is needed to develop further and to maintain a statewide system of quality intervention and treatment services for all persons with autism or other pervasive developmental disorders
- Identifies and monitors apparent gaps in services currently available from various state agencies for persons with autism or other pervasive developmental disorders and advocates improvements on behalf of those persons

- Reports to the governor, lieutenant governor, speaker of the house, and executive commissioner of the Health and Human Services Commission not later than November 1 of each year on recommendations to provide additional or improved services to persons with autism or other pervasive developmental disorders

**Composition:** 4 members

## **Food Protein Committee (Texas Food and Fibers Commission)**

**Legislation:** House Bill 373, Section 5; abolition is effective May 30, 2005

**Function:** Reviewed food protein related research done for the former Texas Food and Fibers Commission, which House Bill 373 replaces with the Food and Fibers Research Council

**Composition:** Up to 25 members

## **Guaranty Association Advisory Committee**

**Legislation:** House Bill 1353, Section 4; abolition is effective September 1, 2005

**Function:** Provided recommendations relating to creation of the Texas Group Self Insurance Guaranty Association, which House Bill 1353 replaces with the Texas Self-Insurance Group Guaranty Fund Board

**Composition:** 6 members

## **Health and Human Services Transition Legislative Oversight Committee (Texas Legislature)**

**Legislation:** Senate Bill 1188, Section 28; abolition is effective September 1, 2005

**Function:** Facilitated the transfer of powers and duties between the state's health and human services agencies and the Health and Human Services Commission following the passage of related legislation in 2003

**Composition:** 7 members

## **Health Care Network Advisory Committee (Texas Workers' Compensation Commission)**

**Legislation:** House Bill 7, Section 7.01(20); abolition is effective September 1, 2005

**Function:** Advised the former Texas Workers' Compensation Commission on the implementation of regional health care delivery networks; House Bill 7 replaces the commission with the Division of Workers' Compensation at the Texas Department of Insurance and authorizes the commissioner of workers' compensation to appoint advisory committees as necessary

**Composition:** 14 members

## **Long-Term Care Legislative Oversight Committee (Texas Legislature)**

**Legislation:** Senate Bill 1188, Section 27; abolition is effective September 1, 2005

**Function:** Monitored the effectiveness and efficiency of the nursing facility regulatory system in Texas; records are transferred to the standing committees of the senate and the house having primary jurisdiction over long-term care services

*Functions are transferred to standing legislative committees.*

**Composition:** 6 members

## **Medical Advisory Committee (Texas Workers' Compensation Commission)**

**Legislation:** House Bill 7, Sections 7.01(21) and 8.012; abolition is effective September 1, 2005

**Function:** Advised the division of medical review of the Texas Workers' Compensation Commission in developing and administering medical policies and fee and utilization guidelines; House Bill 7 transfers powers and duties of the commission to the Division of Workers' Compensation of the Texas Department of Insurance and requires a medical advisor employed by or under contract with that division to create a medical quality review panel

*Functions are transferred to a medical quality review panel at the Division of Workers' Compensation, Texas Department of Insurance.*

**Composition:** 18 members

## **Motor Vehicle Board (Texas Department of Transportation)**

**Legislation:** House Bill 2702, Sections 7.01 and 7.06; abolition is effective June 14, 2005

**Function:** Regulated the sale and distribution of new motor vehicles; activities other than rulemaking are transferred to the director of the Motor Vehicle Division of the Texas Department of Transportation; rulemaking is transferred to the Texas Transportation Commission

*Functions are transferred to the Motor Vehicle Division, Texas Department of Transportation.*

**Composition:** 9 members

### **Natural Fibers Committee (Texas Food and Fibers Commission)**

**Legislation:** House Bill 373, Section 5; abolition is effective May 30, 2005

**Function:** Reviewed natural fiber related research done for the former Texas Food and Fibers Commission, which House Bill 373 replaces with the Food and Fibers Research Council

**Composition:** Up to 25 members

### **Perfusionists, Texas State Board of Examiners of**

**Legislation:** Senate Bill 403; abolition is effective September 1, 2005

**Function:** Regulated perfusionists in Texas and was administratively attached to the Department of State Health Services

*Functions are transferred to the Department of State Health Services, assisted by a new Texas State Perfusionist Advisory Committee.*

**Composition:** 9 members

### **Pharmaceuticals Bulk Purchasing, Interagency Council on**

**Legislation:** Senate Bill 1188, Section 29; abolition is effective September 1, 2007

**Function:** Developed procedures for member agencies to follow in purchasing pharmaceuticals

**Composition:** At least 5 members

### **Psychological Associate Advisory Committee (Texas State Board of Examiners of Psychologists)**

**Legislation:** House Bill 1015, Sections 24 and 25; abolition is effective September 1, 2005

**Function:** Advised the Texas State Board of Examiners of Psychologists on rules relating to psychological associates

**Composition:** 6 members

### **Public Safety Radio Communications Council**

**Legislation:** Senate Bill 9, Sections 22 and 23; abolition is effective June 18, 2005

**Function:** Oversaw the implementation of a statewide integrated public safety radio communications system for public safety and homeland security purposes; the Office of the Governor replaces the council as the entity responsible for oversight of the development of a program related to the interoperability of radio communications

*Functions are transferred to the Office of the Governor.*

**Composition:** 8 members

## **Recycling Market Development Board**

**Legislation:** House Bill 2466; abolition is effective September 1, 2005

**Function:** Coordinated the recycling activities of state agencies; functions and duties are transferred to the Texas Commission on Environmental Quality and the Texas Building and Procurement Commission jointly

*Functions are transferred to the Texas Commission on Environmental Quality and the Texas Building and Procurement Commission.*

**Composition:** At least 2 members

## **State Aircraft Pooling Board**

**Legislation:** House Bill 2702, Section 8.02; abolition is effective June 14, 2005

**Function:** Operated a pool for the custody, control, operation, and maintenance of aircraft owned or leased by the state; powers and duties are transferred to the Texas Department of Transportation

*Functions are transferred to the Texas Department of Transportation.*

**Composition:** 4 members

## **TexasOnline Authority**

**Legislation:** House Bill 2048, Sections 24 and 26; abolition is effective June 18, 2005

**Function:** Implemented a project designated “TexasOnline” to serve as a portal to Texas government electronic resources at the state and local levels

*Functions are transferred to the Department of Information Resources.*

**Composition:** 17 members

## **Work and Family Policies Advisory Committee (Texas Workforce Commission)**

**Legislation:** House Bill 2962, Section 5; abolition is effective May 30, 2005

**Function:** Advised the Texas Workforce Commission on employment-related family issues

**Composition:** Up to 12 members

## **Workers' Compensation Commission, Texas**

**Legislation:** House Bill 7, Sections 1.003 and 8.001; abolition is effective September 1, 2005

**Function:** Administered Texas workers' compensation laws; powers and duties are transferred to the Division of Workers' Compensation of the Texas Department of Insurance

*Functions are transferred to the Division of Workers' Compensation, Texas Department of Insurance.*

**Composition:** 6 members
