

## **Foreword**

Between 1997 and 2003, the Texas Legislative Council publication *Summary of Enactments* included a table to indicate statutory state agencies, interagency panels, advisory committees, and other state governmental entities that were created, restructured, or eliminated by the legislature. *New, Renamed, and Abolished State Governmental Entities* replaced the table in 2005 with an expanded format that provides more information about the affected entities and their functions and composition. An index at the end of this publication provides an opportunity to search for the entities by subject area. The index is preceded by an appendix that addresses entities affected by the passage of Senate Bill 219, which clarified and updated statutory provisions relating to the provision of health and human services in the state.

The **New Entities** section provides information on each of the 47 entities created by the 84th Legislature. Some of these new entities are tied to the abolishment of another entity. In such instances, a reference to the corresponding entity is included.

The **Renamed Entities** section provides information on each of the six entities renamed by the 84th Legislature, including whether an entity's function and composition were unchanged or revised.

The **Abolished Entities** section provides information on each of the 62 entities that were abolished or that were discontinued because the statute creating it was repealed by the 84th Legislature. If the function of the entity was transferred to an already existing entity, that is noted. If the function was assigned to a new entity described in the New Entities section, a reference to the corresponding entity is included.

For each entity included in the publication, the following information is provided:

**Name**—The name of the entity as it appears in the enabling legislation or a descriptive phrase for the entity. If the entity advises or is administratively attached to a state agency, or if a state agency appoints members or provides staff support to the entity, that agency's name appears in parentheses. For an entity that has been renamed, the previous name is indicated. For an abolished entity, if its function is transferred, the entity that assumes that function is also named.

**Legislation**—The bill and specific bill sections that contain provisions creating, renaming, or abolishing the entity and that may contain other information, such as the function and composition.

**Effective/Abolished**—The date the provision creating, renaming, or abolishing the entity becomes effective. If creation of the entity is authorized instead of mandated, that is noted. All bills were enacted during the regular session of the legislature unless otherwise noted.

**Function**—Powers and duties of the entity. For entities that have been renamed, if the function has been revised, a brief explanation of the change is provided. Information about the transfer of the function to another entity is included if applicable.

**Composition**—Membership information for the entity, including the number of members, appointment criteria, and terms of office. Information about the designation or selection of the presiding officer is included if that information is in the bill. If the composition of a renamed entity has been changed, a brief explanation of the change is provided.

**Expiration Date**—When applicable, the sunset date or other expiration date included in the legislation creating a new entity or in the enabling statute for a renamed entity. Section 2110.008, Government Code, relating to the duration of advisory bodies, may be applicable to certain entities.

### **New Entities**

## **ABLE Program Advisory Committee**

(Prepaid Higher Education Tuition Board)

**Legislation:** Senate Bill 1664, Sections 2 and 5 **Effective:** June 19, 2015

#### **Function:**

- Reviews rules and procedures related to the Texas Achieving a Better Life Experience (ABLE) Program
- Provides guidance, suggests changes, and makes recommendations for the administration of the program
- Provides assistance as needed to the Prepaid Higher Education Tuition Board and comptroller of public accounts during the creation of the program

**Composition (5-7 members):** The comptroller appoints at least five and not more than seven members to the advisory committee, including at least one member from each of the following groups:

- Persons with a disability who qualify for the program
- Family members of a person with a disability who qualifies for the program
- Representatives of disability advocacy organizations
- Representatives of the financial community

The comptroller appoints a presiding officer.

Expiration Date: December 1, 2019

## **Advisory Council on Cultural Affairs**

(Office of the Governor)

**Legislation:** Senate Bill 459, Sections 1 and 2 **Effective:** September 1, 2015

#### **Function:**

 Advises the governor's office on setting policy priorities that address and raise public awareness of major issues affecting Texas due to the rapid growth of the state's Hispanic population and other issues resulting from changes in demographics in Texas as determined by the governor

- Studies and makes recommendations relating to the effect of the changing demographics of Texas on the economy, the workplace, educational attainment, health, veterans affairs, and political leadership in Texas
- Not later than October 1 of each even-numbered year, submits a report of the council's recommendations to the governor, the lieutenant governor, and the speaker of the house

#### Composition (9 members total):

- 1 ex officio member of the legislature appointed by the speaker of the house
- 1 ex officio member of the legislature appointed by the lieutenant governor
- 7 members appointed by the governor

Members appointed by the speaker of the house and the lieutenant governor serve twoyear terms. Members appointed by the governor serve four-year staggered terms, with either three or four members' terms expiring February 1 of each odd-numbered year. In making appointments to the council, the appointing officials must attempt to achieve representation of all areas of the state. The governor designates the chair and vice chair of the council from among the members of the council.

## **Commission to Study Non-Criminal Penal Laws**

**Legislation:** House Bill 1396, Section 29 **Effective:** September 1, 2015

#### **Function:**

- Studies, evaluates, and reviews all state penal laws, other than criminal offenses under the Penal Code, under the Texas Controlled Substances Act, or related to the operation of a motor vehicle
- Makes recommendations to the legislature regarding the repeal of laws that are identified
  as being unnecessary, unclear, duplicative, overly broad, or otherwise insufficient to
  serve the intended purpose of the law
- Not later than November 1, 2016, submits a report on the commission's findings and recommendations to the governor, the lieutenant governor, the speaker of the house, the Supreme Court of Texas, the Texas Court of Criminal Appeals, and the standing committees of the house and the senate with primary jurisdiction over criminal justice

#### Composition (9 members total):

- 2 members appointed by the governor
- 2 members appointed by the lieutenant governor
- 2 members appointed by the speaker of the house
- 2 members appointed by the chief justice of the Supreme Court of Texas

• 1 member appointed by the presiding judge of the Texas Court of Criminal Appeals

The governor designates one member of the commission to serve as the presiding officer. The officials making appointments to the commission must ensure that the membership includes representatives of all areas of the criminal justice system, including prosecutors, defense attorneys, judges, legal scholars, and relevant business interests.

Expiration Date: December 31, 2016

## **Dietitians Advisory Board**

(Texas Department of Licensing and Regulation)

**Legislation:** Senate Bill 202, Sections 1.191-1.197. The new entity is established in Subchapter B, Chapter 701, Occupations Code, which contains revised language relating to the Texas State Board of Examiners of Dietitians, which was abolished by Senate Bill 202.

Effective: September 1, 2015

**Function:** Provides advice and recommendations to the Texas Department of Licensing and Regulation (TDLR) on technical matters relevant to the administration of the Licensed Dietitian Act

#### Composition (9 members total):

- 6 licensed dietitian members, each of whom has been licensed for not less than three years before the member's date of appointment
- 3 public members

The presiding officer of TDLR, with the approval of the Texas Commission of Licensing and Regulation, appoints the members of the board. Members serve staggered six-year terms with the terms of three members beginning on September 1 of each odd-numbered year. In appointing members, the presiding officer of TDLR must attempt to maintain a balanced representation among specified primary areas of expertise included in the professional discipline of dietetics. The presiding officer of TDLR designates a member of the advisory board as the presiding officer of the advisory board to serve a one-year term. The presiding officer of the advisory board may vote on any matter before the advisory board.

## **Driver and Traffic Safety Education Advisory Committee**

(Texas Commission of Licensing and Regulation)

**Legislation:** House Bill 1786, Sections 13 and 72 **Effective:** September 1, 2015

**Function:** Advises the Texas Commission of Licensing and Regulation and the Texas Department of Licensing and Regulation on rules and educational and technical matters relevant to driver and traffic safety education

**Composition (11 members total):** Members are appointed by the presiding officer of the commission, with the approval of the commission, as follows:

- 1 member representing a driver education school that offers a traditional classroom course and in-car training
- 1 member representing a driver education school that offers a traditional classroom course, alternative methods of instruction, or in-car training
- 1 member representing a driving safety school offering a traditional classroom course or providing an alternative method of instruction
- 1 member representing a driving safety course provider approved for a traditional classroom course and for an alternative method of instruction
- 1 member representing a driving safety course provider approved for a traditional classroom course or for an alternative method of instruction
- 1 licensed instructor
- 1 representative of the Department of Public Safety
- 1 member representing a drug and alcohol driving awareness program course provider
- 1 member representing a parent-taught course provider
- 2 members representing the public

Members are appointed for staggered six-year terms but may not serve two consecutive full terms. The presiding officer of the commission appoints the presiding officer of the advisory committee, who may vote on any matter before the advisory committee.

## **Economic Incentive Oversight Board**

**Legislation:** House Bill 26, Article 2, Section 2.01 **Effective:** September 1, 2015

#### **Function:**

- Examines the effectiveness and efficiency of certain state incentive programs and funds administered by the office of the governor, the comptroller of public accounts, or the Department of Agriculture (TDA) that award to business entities and other persons state monetary or tax incentives for which the governor, comptroller, or TDA has discretion in determining whether or not to award the incentives
- Develops a schedule for the periodic review of each applicable state incentive program or fund to make recommendations on whether to continue the program or fund or whether to improve program or fund effectiveness and efficiency
- May recommend to the legislative audit committee that an audit of a program or fund be included in the annual audit plan conducted by the State Auditor's Office

 Not later than January 1 of each odd-numbered year, submits a report to the lieutenant governor, the speaker of the house, and each standing committee of the senate and house with primary jurisdiction over economic development containing findings and recommendations resulting from each review of state incentive programs and funds conducted by the board during the preceding two calendar years

#### Composition (9 members total):

- 2 public members appointed by the speaker of the house, one of whom must be from a rural county
- 2 public members appointed by the lieutenant governor, one of whom must be from a rural county
- 2 public members appointed by the comptroller of public accounts
- 3 public members appointed by the governor

In appointing members of the board, each appointing officer must appoint one member with expertise in the area of economic development. The governor appoints the presiding officer of the board.

## **Epinephrine Auto-Injectors in Schools Advisory Committee**

(Department of State Health Services)

**Legislation:** Senate Bill 66, Section 2 **Effective:** May 28, 2015

#### **Function:**

- Examines and reviews the administration of epinephrine auto-injectors to a person experiencing an anaphylactic reaction on a campus of a school district or an openenrollment charter school
- Advises the commissioner of state health services on the storage and maintenance
  of epinephrine auto-injectors on school campuses, the training of school personnel
  and school volunteers in the administration of an epinephrine auto-injector, and a
  plan for one or more school personnel members or school volunteers trained in the
  administration of an epinephrine auto-injector to be on each school campus

Composition (unspecified number of members): The advisory committee is composed of members appointed by the commissioner of state health services. In making appointments, the commissioner must ensure that a majority of the members are physicians with expertise in treating anaphylaxis, including physicians who specialize in the fields of pediatrics, allergies, asthma, and immunology, and that at least one member is a registered nurse employed by a school district or open-enrollment charter school as a school nurse. The advisory committee elects a presiding officer.

## **Forensic Mental Health Services Work Group**

(Department of State Health Services)

**Legislation:** Senate Bill 1507, Sections 1 and 4 **Effective:** May 28, 2015

#### **Function:**

- Makes recommendations concerning the creation of a comprehensive plan for the effective coordination of forensic services
- Not later than July 1, 2016, sends a report, describing the work group's recommendations to the lieutenant governor, the speaker of the house, and the standing committees of the senate and the house with primary jurisdiction over forensic services

**Composition (at least 9 members):** The commissioner of state health services selects the total number of members at the time the commissioner establishes the work group. The executive commissioner of the Health and Human Services Commission appoints as members of the work group:

- 1 representative of the Department of State Health Services
- 1 representative of the Texas Department of Criminal Justice
- 1 representative of the Texas Juvenile Justice Department
- 1 representative of the Texas Correctional Office on Offenders with Medical or Mental Impairments
- 1 representative of the Sheriffs' Association of Texas
- 1 superintendent of a state hospital with a maximum security forensic unit
- 1 representative of a local mental health authority
- 1 representative of the protection and advocacy system of the state, appointed by the administrative head of that system
- Additional members as needed to comply with the number of members selected by
  the commissioner of state health services, who must be recognized experts in forensic
  patients or persons who represent the interests of forensic patients, and who may be
  advocates, family members, psychiatrists, psychologists, social workers, psychiatric
  nurses, or representatives of a hospital licensed under the Texas Hospital Licensing Law
  or a mental hospital licensed by the Department of State Health Services

Expiration Date: November 1, 2019

## Governor's University Research Initiative Advisory Board

(Texas Economic Development and Tourism Office)

**Legislation:** House Bill 7, Section 11 **Effective:** September 1, 2015

#### **Function:**

- Assists the office of the governor with the review and evaluation of applications submitted by eligible institutions of higher education for funding of grant proposals regarding financial assistance from the governor's university research initiative fund for the recruitment of distinguished researchers
- Makes timely recommendations to the office for approval or disapproval of those applications

**Composition (at least 9 members):** The advisory board's members are appointed by the governor. As nearly as possible, one-third of the members must have a background in finance, one-third must have an academic background in science, technology, engineering, or mathematics, and one-third must be public members.

### **Health and Human Services Commission Executive Council**

(Health and Human Services Commission)

**Legislation:** Senate Bill 200, Section 1.03 **Effective:** September 1, 2015

#### **Function:**

- Advises the executive commissioner of the Health and Human Services Commission (HHSC) regarding the operation of HHSC
- Seeks and receives public comment on proposed rules, recommendations of advisory committees, legislative appropriations requests or other documents related to the appropriations process, the operation of health and human services programs, and other items the executive commissioner determines appropriate

#### Composition (unspecified number of members):

- The executive commissioner of HHSC, who serves as council chair
- The director of each division of HHSC
- The commissioner of a health and human services agency
- Other individuals appointed by the executive commissioner as the executive commissioner determines necessary

To the extent the executive commissioner appoints members to the council, the executive commissioner must make every effort to ensure that those appointments result in a council membership that includes a balanced representation of a broad range of health

and human services industry and consumer interests and representation from broad geographic regions of Texas.

## Health and Human Services Transition Legislative Oversight Committee (Health and Human Services Commission)

**Legislation:** Senate Bill 200, Sections 1.01 and 1.10 **Effective:** September 1, 2015

#### **Function:**

- Facilitates the transfer of functions resulting from the consolidation of the health and human services system in general, the transfer of certain functions to the Health and Human Services Commission (HHSC), and the transfer and consolidation of certain administrative support services functions
- With assistance from HHSC and the state agencies and entities whose functions are transferred, advises the executive commissioner of HHSC concerning the functions to be transferred and the funds and obligations that are related to the functions; the transfer of the functions and related records, property, funds, and obligations by the affected state agencies and entities; and any required reorganization of HHSC's administrative structure
- Submits a report, not later than December 1 of each even-numbered year, to the governor, the lieutenant governor, the speaker of the house, and the legislature containing an update on the progress of and issues related to the transfer and consolidation of functions and the reorganization of HHSC's administrative structure
- Reviews the report and recommendation resulting from the executive commissioner's study on the need to continue the Department of Family and Protective Services and the Department of State Health Services as state agencies separate from HHSC and, not later than December 1, 2018, submits a report and recommendation to the legislature regarding such continuation

#### Composition (11 members total):

- 4 state senators, appointed by the lieutenant governor
- 4 state representatives, appointed by the speaker of the house
- 3 public members, appointed by the governor

The executive commissioner of HHSC serves as an ex officio, nonvoting member of the committee. The lieutenant governor and the speaker of the house must each designate a presiding co-chair from among their respective appointments.

**Expiration Date:** September 1, 2023

## **Hearing Instrument Fitters and Dispensers Advisory Board**

(Texas Department of Licensing and Regulation)

**Legislation:** Senate Bill 202, Sections 1.082-1.088. The new entity is established in Subchapter B, Chapter 402, Occupations Code, which contains revised language relating to the State Committee of Examiners in the Fitting and Dispensing of Hearing Instruments, which was abolished by Senate Bill 202.

Effective: September 1, 2015

**Function:** Provides advice and recommendations to the Texas Department of Licensing and Regulation (TDLR) on technical matters relevant to the regulation of hearing instrument fitters and dispensers

**Composition (9 members total):** Members are appointed by the presiding officer of the Texas Commission of Licensing and Regulation, with the commission's approval, as follows:

- 6 members licensed as hearing instrument fitters and dispensers who have been Texas
  residents actually engaged in fitting and dispensing hearing instruments for at least five
  years preceding appointment, not more than one of whom may be licensed as a speechlanguage pathologist or audiologist
- 1 member who is actively practicing as a physician licensed by the Texas Medical Board and who has been a Texas resident for at least two years preceding appointment, is a citizen of the United States, and specializes in the practice of otolaryngology
- 2 public members

Members serve staggered six-year terms with the terms of three members expiring on February 1 of each odd-numbered year. The presiding officer of the Texas Commission of Licensing and Regulation designates a member to serve as the presiding officer for a term of one year.

## House Select Committee on State Real Property Data Collection, Reporting, and Assessment

**Legislation:** House Bill 3750, Section 2

Effective: June 19, 2015

#### **Function:**

- Studies, separately or jointly with the Senate Select Committee on State Real Property Data Collection, Reporting, and Assessment:
  - the potential benefits of maintaining a comprehensive database of all real property owned by the state

- the potential financial loss to the state that could result from the state owning uninsured and underinsured real property

## **Interagency Data Transparency Commission**

**Legislation:** Senate Bill 1844, Sections 1 and 2 **Effective:** September 1, 2015

• Studies and reviews the current public data structure, classification, sharing, and reporting protocols for state agencies and the possibility of collecting and posting data from state agencies online in an open source format that is machine-readable, exportable, and easily accessible by the public

- 2 representatives from the Department of Information Resources (DIR), appointed by the executive director of DIR

- 1 representative of the Legislative Budget Board (LBB), appointed by the director of the LBB
- 1 member of each committee of the house and the senate with primary jurisdiction over information resources, appointed by the chair of each committee
- The chair of the State Agency Coordinating Committee established by DIR, or a member of the committee appointed by the chair
- 1 representative of the comptroller of public accounts, appointed by the comptroller
- 1 representative appointed by the governor, who serves as the presiding officer of the commission
- 1 representative appointed by the lieutenant governor
- 1 representative appointed by the speaker of the house

## Joint Interim Committee to Study Border Security

**Legislation:** House Bill 11, Section 17 **Effective:** September 1, 2015

**Function:** Conducts a study on border security and submits a report, including findings and recommendations, to the 85th Legislature before it convenes in regular session in January of 2017

#### Composition (10 members total):

- 5 state senators appointed by the lieutenant governor
- 5 state representatives appointed by the speaker of the house

The lieutenant governor and speaker of the house must each designate a co-chair from among the committee members.

## Joint Interim Committee to Study a Coastal Barrier System

**Legislation:** Senate Bill 695, Section 1. House Bill 3459, Acts of the 83rd Legislature, 2013, initially created an interim committee to study this issue.

Effective: September 1, 2015

#### **Function:**

- Continues to study the feasibility and desirability of creating and maintaining a coastal barrier system in Texas that includes a series of gates and barriers to prevent storm surge damage to gulf beaches or coastal ports, industry, or property
- Not later than December 1, 2016, reports to the governor and the legislature the findings of the study and any recommendations developed by the committee

#### Composition (unspecified number of members):

- The members of the standing committee of the senate that has primary jurisdiction over natural resources
- The members of the standing committee of the house of representatives that has primary jurisdiction over land and resource management
- 2 state senators appointed by the lieutenant governor, each of whom represents a district in a county that borders the Gulf of Mexico
- 2 state representatives appointed by the speaker of the house, each of whom represents a district in a county that borders the Gulf of Mexico

The lieutenant governor and the speaker of the house jointly designate a chair, or alternatively, designate two co-chairs from among the committee membership.

## Joint Interim Committee to Study Teacher Retirement System of Texas (TRS) Health Benefit Plans

Legislation: House Bill 2974, Section 9; Senate Bill 1940, Section 1

Effective: September 1, 2015

#### **Function:**

- Studies and reviews the health benefit plans, including TRS-Care and TRS-ActiveCare, operated under the Texas School Employees Uniform Group Health Coverage Act and the Texas Public School Retired Employees Group Benefits Act, to examine and assess the financial soundness of the plans, the cost and affordability of plan coverage to persons eligible for coverage under the plans, and the sufficiency of access to physicians and health care providers under the plans
- Proposes reforms to address the issues of study
- With regard to TRS-ActiveCare, studies:
  - the impact of allowing school districts and other participating entities in the uniform group coverage program for active employees to opt out of that program
  - the impact, should participating entities be authorized to opt out of the program, of allowing or prohibiting future participation by previous participating entities that have opted out
  - the impact of establishing a regional rating method for determining premiums charged in different regions of the state for the benefits provided under a group coverage plan established under the program
- Not later than January 15, 2017, reports its findings and recommendations, including specific statutory and regulatory changes that appear necessary from the results of the committee's study on the TRS health benefit plans, to the governor, the lieutenant governor, and the speaker of the house

#### Composition (6 members total):

- 3 state senators appointed by the lieutenant governor
- 3 state representatives appointed by the speaker of the house

The lieutenant governor and speaker of the house each designate a co-chair from among the committee members.

Expiration Date: January 20, 2017

## Joint Oversight Committee on Government Facilities

**Legislation:** Senate Bill 2004, Section 1 **Effective:** May 28, 2015

#### **Function:**

 Reviews deferred maintenance plans for state facilities and receives implementation updates

Provides a biannual written status report to the legislature that includes the amount
of money expended from the deferred maintenance fund, the deferred maintenance
projects to be completed through expenditures from the fund, and the status of ongoing
and completed projects

#### Composition (6 members total):

- 3 state senators appointed by the lieutenant governor
- 3 state representatives appointed by the speaker of the house

The committee chair alternates annually between a state senator appointed by the lieutenant governor and a state representative appointed by the speaker of the house.

Expiration Date: January 8, 2019

## **Juvenile Records Advisory Committee**

(Texas Juvenile Justice Board)

**Legislation:** House Bill 431, Sections 1-7 **Effective:** May 28, 2015

#### **Function:**

• Develops a plan for studying, reorganizing, and comprehensively revising Family Code provisions relating to the juvenile justice information system and any other relevant laws pertaining to juvenile records

Not later than November 1, 2016, submits recommendations for such revisions and a copy
of the plan developed by the advisory committee to produce those recommendations to
the legislature and the Texas Juvenile Justice Board

**Composition (unspecified number of members):** In making appointments, the board must include members who are interested parties, including the following:

- Chief justice probation officers
- Juvenile prosecutors
- Juvenile defense attorneys
- Juvenile court judges

- Justice court or municipal court judges
- Court administrators or court clerks
- Peace officers
- Representatives of the Department of Public Safety
- Representatives of the Department of Family and Protective Services
- Representatives of the Texas Juvenile Justice Department
- Juvenile justice advocates
- Individuals with expertise in federal records and federal immigration policy
- Public members
- Any other individuals that the board considers necessary to accomplish the duties of the advisory committee

The board designates one of the members as presiding officer of the advisory committee.

## Long-Term Care Facility Survey and Informal Dispute Resolution Council (Health and Human Services Commission)

**Legislation:** Senate Bill 914, Sections 1-8 **Effective:** September 1, 2015

#### **Function:**

- Studies and makes recommendations regarding a consistent survey and informal dispute resolution process for long-term care facilities and best practices and protocols to make survey, inspection, and informal dispute resolution processes more efficient and less burdensome on long-term care facilities

- 2 program managers from different Department of Aging and Disability Services (DADS) regions
- 1 surveyor who has attained at least the level of investigator IV
- 2 members of an enforcement team from different DADS regions

- 3 surveyors, each from a different DADS region, at least one of whom must have a background in nursing, at least one of whom must have a background in social work, and at least one of whom must have a background in the provision of pharmacy services
- 1 informal dispute resolution team leader
- 1 informal dispute resolution reviewer
- 2 owners or regional vice presidents of operation who oversee multiple long-term care facilities
- 2 regional quality assurance nurses who oversee multiple long-term care facilities
- 2 active long-term care facility administrators
- 2 active long-term care facility directors of nursing

Members are appointed by the executive commissioner of HHSC, who designates a member of the council to serve as presiding officer.

## **Medical Physicist Licensure Advisory Committee**

(Texas Medical Board)

**Legislation:** Senate Bill 202, Sections 2.048-2.059. The new entity is established in Subchapter B, Chapter 602, Occupations Code, which contains revised language relating to the Texas Board of Licensure for Professional Medical Physicists, which was abolished by Senate Bill 202.

Effective: September 1, 2015

Function: Serves as an informal advisory committee to the Texas Medical Board

#### Composition (7 members total):

- 4 medical physicists licensed in Texas who each have at least five years of experience as a medical physicist
- 2 physicians licensed in Texas who each have at least five years of clinical experience related to medical physics
- 1 public member

Appointments to the advisory committee are made by the board's president and members serve two-year terms that expire on February 1 of each odd-numbered year. A person is not eligible to serve more than two consecutive full terms. The board's president biennially designates a member of the advisory committee to serve as the presiding officer.

## **Midwives Advisory Board**

(Texas Department of Licensing and Regulation)

Effective: September 1, 2015

**Function:** Provides advice and recommendations to the Texas Department of Licensing and Regulation on technical matters relevant to the administration of the Texas Midwifery Act

**Composition (9 members total):** Appointments to the advisory board are made by the presiding officer of the Texas Commission of Licensing and Regulation with the approval of the commission as follows:

- 5 licensed midwife members each of whom has at least three years' experience in the practice of midwifery
- 1 physician member who is certified by a national professional organization of physicians that certifies obstetricians and gynecologists
- 1 physician member who is certified by a national professional organization of physicians that certifies family practitioners or pediatricians
- 2 public members who are not practicing or trained in a health care profession, one of whom is a parent with at least one child born with the assistance of a midwife

The presiding officer designates a public member of the advisory board to serve as the advisory board's presiding officer for a term of one year. The presiding officer of the advisory board may vote on any matter before the advisory board. Members serve for staggered terms of six years with the terms of three members expiring on January 31 of each odd-numbered year.

## **Orthotists and Prosthetists Advisory Board**

(Texas Department of Licensing and Regulation)

**Legislation:** Senate Bill 202, Sections 1.167-1.172. The new entity is established in Subchapter B, Chapter 605, Occupations Code, which contains revised language relating to the Texas Board of Orthotics and Prosthetics, which was abolished by Senate Bill 202.

Effective: September 1, 2015

**Function:** Provides advice and recommendations to the Texas Department of Licensing and Regulation on technical matters relevant to the regulation of orthotists and prosthetists

**Composition (7 members total):** Appointments to the advisory board are made by the presiding officer of the Texas Commission of Licensing and Regulation, with the approval of the commission, as follows:

- 2 licensed orthotist members who each have practiced orthotics for the five years preceding the date of appointment
- 2 licensed prosthetist members who each have practiced prosthetics for the five years preceding the date of appointment
- 1 licensed prosthetist orthotist member who has practiced orthotics and prosthetics for the five years preceding the date of appointment
- 1 public member who uses an orthosis
- 1 public member who uses a prosthesis

Members serve staggered six-year terms with the terms of two or three members expiring on February 1 of each odd-numbered year. The members elect from the advisory board's membership a presiding officer to serve for a term of one year. The presiding officer may vote on any matter before the advisory board.

## **Palliative Care Interdisciplinary Advisory Council**

(Health and Human Services Commission)

**Legislation:** House Bill 1874, Sections 2 and 3 **Effective:** June 9, 2015

- Consults with and advises the Health and Human Services Commission (HHSC) on matters related to the establishment, maintenance, operation, and outcome evaluation of the statewide palliative care consumer and professional information and education program
- Not later than October 1 of each even-numbered year, submits a report on certain assessments and analyses conducted by the advisory council to the standing committees of the senate and the house of representatives with primary jurisdiction over health matters

**Composition (at least 15 members):** Members are appointed by the executive commissioner of HHSC and must include the following members:

- At least 5 physician members, including 2 who are board certified in hospice and palliative care and 1 who is board certified in pain management
- 3 palliative care practitioner members, including 2 advanced practice registered nurses who are board certified in hospice and palliative care and 1 physician assistant who has experience providing palliative care

- 4 health care professional members, including a nurse, a social worker, a pharmacist, and a spiritual care professional, all with experience providing palliative care to pediatric, youth, or adult populations; expertise in palliative care delivery in an inpatient, outpatient, or community setting; or expertise in interdisciplinary palliative care
- At least 3 members with experience as an advocate for patients and the patients' family caregivers and who are independent of a hospital or other health care facility, including at least 1 member who is a representative of an established patient advocacy organization
- Ex officio representatives of HHSC or another state agency as the executive commissioner determines appropriate

Advisory council members elect a chair and a vice chair and establish the duties of these positions. Advisory council members serve four-year terms.

## **Perfusionist Licensure Advisory Committee**

(Texas Medical Board)

**Legislation:** Senate Bill 202, Sections 2.090-2.099. The new entity is established in Subchapter B, Chapter 603, Occupations Code, which contains revised language relating to the Texas State Perfusionist Advisory Committee, which was abolished by Senate Bill 202.

Effective: September 1, 2015

Function: Serves as an informal advisory committee to the Texas Medical Board

**Composition (7 members total):** Appointments to the advisory committee are made by the board's president as follows:

- 4 perfusionists licensed in Texas who each have at least five years of experience as a perfusionist
- 2 physicians licensed in Texas who supervise perfusionists
- 1 public member

Members serve two-year terms that expire on February 1 of each odd-numbered year. The board's president designates biennially an advisory committee member as the presiding officer to serve in that capacity at the will of the president. The advisory committee may appoint additional officers as necessary.

## **Purchasing From People With Disabilities Advisory Committee**

(Texas Workforce Commission)

**Legislation:** Senate Bill 212, Sections 5, 6, and 30. The new entity is established in Section 122.0057, Human Resources Code, which contains revised language relating to the Texas Council on Purchasing From People With Disabilities, which was abolished by Senate Bill 212.

Effective: September 1, 2015

#### **Function:**

- Assists the Texas Workforce Commission (TWC) in establishing performance goals for the State Use Program and criteria for certifying a community rehabilitation program for participation in the program
- Establishes specific objectives for the program that are appropriate given the program's status as one of several employment-related services Texas offers to persons with disabilities
- Develops performance measures that may be used by the TWC to evaluate whether the program is meeting those objectives
- Recommends criteria for certifying community rehabilitation programs for participation in the program
- Recommends changes to the program objectives, performance measures, and criteria as necessary
- Provides input to the TWC in adopting rules applicable to the program relating to the state's employment-first policies

#### **Composition (13 members total):** The TWC appoints the following:

- 4 representatives from community rehabilitation programs that participate in the State Use Program
- 4 representatives from organizations that advocate for persons with disabilities
- The executive commissioner of the Health and Human Services Commission or the executive commissioner's designee
- 4 persons with disabilities, two of whom are employed by a community rehabilitation program that participates in the State Use Program

The TWC appoints a presiding officer from among the advisory committee members. The members of the advisory committee serve staggered four-year terms, with the terms of either six or seven members expiring February 1 of each odd-numbered year. A member may not serve more than two terms.

**Function:** Provides advice and recommendations to the Texas Department of Licensing and Regulation (TDLR) on technical matters relevant to the regulation of speech-language pathologists and audiologists

**Composition (9 members total):** Appointments to the advisory board are made by the presiding officer of the Texas Commission of Licensing and Regulation, with the approval of the commission, as follows:

- 3 audiologist members who are licensed by TDLR and have been engaged in teaching, research, or providing services in audiology for at least five years
- 3 speech-language pathologist members who are licensed by TDLR and have been engaged in teaching, research, or providing services in speech-language pathology for at least five years
- 3 public members, at least one of whom must be a physician licensed in Texas and certified in otolaryngology or pediatrics

The members of the advisory board serve staggered six-year terms. The terms of three members expire September 1 of each odd-numbered year. Members must have been a Texas resident for the two years preceding the date of appointment, be from the various

geographic regions of Texas, and be from varying employment settings. The commission's presiding officer designates a member to serve as the presiding officer for a term of one year. The presiding officer may vote on any matter before the advisory board.

## Task Force on Improving Outcomes for Juveniles Adjudicated of Sexual Offenses

**Legislation:** House Bill 1144, Sections 1-4 **Effective:** June 17, 2015

#### **Function:**

- Makes policy recommendations to improve the outcomes for juvenile sex offenders
- Solicits and reviews information and hears relevant testimony from individuals, state and local agencies, community-based organizations, and other public and private organizations
- Reviews the adjudication and disposition processes and programs for juvenile sex offenders; juvenile sex offender registration; counseling, mental health, or other services provided to juvenile sex offenders; and statistical information regarding the frequency of juvenile sex offenders being victims of abuse or neglect or witnesses to family violence
- Prepares and, not later than December 1, 2016, submits a report to the governor; the lieutenant governor; the speaker of the house; the standing committees of each house of the legislature with primary jurisdiction over criminal justice matters; the executive director of the Texas Department of Criminal Justice; the executive director of the Texas Juvenile Justice Department; each state agency and nonprofit organization represented on the task force; and any other appropriate agency in Texas

#### Composition (20 members total):

- The executive director of the Texas Juvenile Justice Department or the executive director's designee
- The commissioner of the Department of Family and Protective Services or the commissioner's designee
- 1 representative designated by the Crime Records Service of the Department of Public Safety (DPS) who has experience with DPS's sex offender registry
- 1 representative designated by the Council on Sex Offender Treatment
- 1 representative designated by Children's Advocacy Centers of Texas
- 1 representative designated by the Texas Association for the Protection of Children
- 1 representative designated by Texans Care for Children

- 1 private provider of juvenile sex offender treatment from a rural county and 1 private provider of juvenile sex offender treatment from an urban county, appointed by the governor
- 1 judge from a rural county and 1 judge from an urban county, appointed by the governor
- 1 law enforcement official from a rural county and 1 law enforcement official from an urban county, appointed by the governor
- 1 prosecutor from a rural county and 1 prosecutor from an urban county, appointed by the governor
- 1 juvenile probation officer from a rural county and 1 juvenile probation officer from an urban county, appointed by the governor
- 1 juvenile public defender from a rural county and 1 juvenile public defender from an urban county, appointed by the governor
- 1 academic researcher from an accredited university who specializes in juvenile justice, appointed by the governor

The governor designates a member of the task force to serve as presiding officer, and the presiding officer may designate additional experts to serve as advisors to the task force.

## Task Force on Infectious Disease Preparedness and Response

(Office of the Governor)

**Legislation:** House Bill 2950, Section 1 **Effective:** June 19, 2015

#### **Function:**

- Serves as an advisory panel to the governor
- Provides expert, evidence-based assessments, protocols, and recommendations related to state responses to infectious diseases, including Ebola
- Serves as a reliable and transparent source of information and education for Texas leadership and citizens
- May make written reports on its findings and recommendations to the governor and the legislature

**Composition (at least 6 members):** The governor may appoint members of the task force as necessary, but must appoint the following:

 At least 1 member who is a county judge of a county with a population of less than 100,000

- At least 1 member who is a county judge of a county with a population of 100,000 or more
- At least 1 member who is a representative of a local health authority serving a rural area
- At least 1 member who is a representative of a local health authority serving an urban area
- At least 1 member who is a licensed nurse
- At least 1 member who is emergency medical services personnel

The governor appoints a director of the task force from among its members. A member serving on the Task Force on Infectious Disease Preparedness and Response created by executive order of the governor continues to serve on the Task Force on Infectious Disease Preparedness and Response added by House Bill 2950.

# Task Force to Promote Uniformity in Collection and Reporting of Information on Family Violence, Sexual Assault, Stalking, and Human Trafficking

**Legislation:** House Bill 2455, Sections 1 and 2 **Effective:** June 16, 2015

#### **Function:**

- Solicits and receives reports and testimony from individuals, state and local agencies, community-based organizations, and other public and private organizations
- Develops policy recommendations and best practices guidelines for the uniform collection and reporting of information relating to family violence, sexual assault, stalking, and human trafficking, and the implementation of dating violence training and awareness education in public schools
- Not later than September 1, 2016, submits a report to the governor, the lieutenant governor, the speaker of the house, and the appropriate standing committees of the legislature that includes a description of the activities of the task force, its findings and recommendations, and any other matter the task force considers appropriate

#### Composition (at least 17 members):

- 1 member from the Office of Court Administration of the Texas Judicial System, appointed by the administrative director of the courts, who also serves as the task force's presiding officer
- 16 members appointed by the presiding officer of the task force as follows:
  - 1 member from the bureau of identification and records of the Department of Public Safety
  - 1 member from a statewide family violence advocacy organization

- 1 member from a statewide sexual assault advocacy organization
- 1 member who is a prosecuting attorney with experience in obtaining protective orders in cases involving family violence, sexual assault, stalking, or human trafficking
- 1 member who is a magistrate with experience in issuing orders for emergency protection
- 1 member who is a judge or an associate judge with experience in issuing protective orders in cases involving family violence, sexual assault, stalking, or human trafficking
- 1 member from The University of Texas School of Law Domestic Violence Clinic
- 1 member who is from an organization that receives federal funding under the legal assistance for victims grant program and who has expertise in issues related to family violence, sexual assault, or stalking
- 2 members from a law enforcement agency, including 1 member who is a constable
- 1 member from the Texas Center for the Judiciary
- 1 member from the Texas Municipal Courts Education Center
- o 1 member from the Texas Justice Court Training Center
- 1 member from the County and District Clerks' Association of Texas
- 1 member from the child support division of the office of the attorney general
- 1 member from the Texas Education Agency
- Any other member whom the presiding officer determines to be appropriate and who consents to serve on the task force

Expiration Date: September 1, 2017

# Technical Advisory Committee to the Bureau of Economic Geology (Bureau of Economic Geology)

**Legislation:** House Bill 2, Section 16 **Effective:** June 20, 2015

#### **Function:**

- Advises the Bureau of Economic Geology on the use of money appropriated out of the general revenue fund to The University of Texas at Austin for the purchase and deployment of seismic equipment, maintenance of seismic networks, and modeling of reservoir behavior for systems of wells in the vicinity of faults
- Determines the amount of money the bureau uses to enter into collaborative research relationships with other universities

• Advises on the preparation of the bureau's report to be delivered not later than December 1, 2016, to the governor, the House Energy Resources Committee, and the Senate Natural Resources and Economic Development Committee

**Composition (9 members total):** Members are appointed by the governor, at least two of whom represent higher education institutions and have seismic or reservoir modeling experience, at least two of whom are experts from the oil and gas industry, and at least one of whom is a Railroad Commission of Texas seismologist.

## **Texas Adult Stem Cell Research Coordinating Board**

**Legislation:** House Bill 177, Sections 1 and 6 **Effective:** September 1, 2015

#### **Function:**

• Establishes the Texas Adult Stem Cell Research Consortium composed of participating institutions of higher education and businesses that accept public money for adult stem cell research or otherwise agree to participate in the consortium

- Administers the adult stem cell research program and develops research priorities, guidelines, and procedures for providing grants and loans for specific research projects conducted by consortium members
- Not later than September 1 of each even-numbered year, submits a report of the board's
  activities and recommendations to the Texas Higher Education Coordinating Board and
  to the governor, the lieutenant governor, the speaker of the house, and the presiding
  officer of each legislative standing committee or subcommittee with jurisdiction over
  higher education

#### Composition (7 members total):

- 3 members who are interested persons, including at least 1 person who represents an institution of higher education and 1 person who is a representative of an advocacy organization representing patients, appointed by the governor, with the advice and consent of the senate
- 2 members who are interested persons appointed by the lieutenant governor
- 2 members who are interested persons appointed by the speaker of the house

The governor designates as the presiding officer a board member who represents an institution of higher education. The members serve staggered six-year terms.

## Texas Board of Medical Radiologic Technology

(Texas Medical Board)

Legislation: Senate Bill 202, Sections 2.003-2.009, 2.011-2.025, 2.027-2.030, and 2.035-2.047

**Effective:** September 1, 2015

#### **Function:**

Advises the Texas Medical Board

 Adopts rules to establish a certification program for medical radiologic technologists and administers and regulates the program

**Composition (9 members total):** The governor appoints advisory board members, with the advice and consent of the senate, as follows:

- 4 medical radiologic technologists who each have at least five years of experience as a medical radiologic technologist
- 2 physicians licensed in Texas who supervise medical radiologic technologists
- 3 public members

Members are appointed for staggered six-year terms with the terms of three members expiring on February 1 of each odd-numbered year. A member may not serve more than two consecutive full terms or a total of three full terms. The governor designates a member of the advisory board as the presiding officer to serve in that capacity at the will of the governor. The advisory board must select from its membership an assistant presiding officer and other officers as it considers necessary to carry out its duties. The presiding officer appoints a three-member disciplinary panel consisting of advisory board members to determine whether a certificate should be temporarily suspended.

# **Texas Board of Respiratory Care**

(Texas Medical Board)

**Legislation:** Senate Bill 202, Sections 2.149-2.196. The new entity is established in Subchapter A-1, Chapter 604, Occupations Code.

Effective: September 1, 2015

#### **Function:**

- Advises the Texas Medical Board
- Adopts rules to establish a certification and permitting program for respiratory care practitioners and administers and regulates the program

**Composition (9 members total):** The governor appoints advisory board members, with the advice and consent of the senate, as follows:

- 4 respiratory care practitioners who each have at least five years of experience as a respiratory care practitioner
- 2 physicians licensed in Texas who supervise respiratory care practitioners
- 3 public members

Members are appointed for staggered six-year terms with the terms of three members expiring on February 1 of each odd-numbered year. A member may not serve more than two consecutive full terms or a total of three full terms. The governor designates a member as the presiding officer to serve in that capacity at the will of the governor. The advisory board selects from its membership an assistant presiding officer and other officers as it considers necessary to carry out its duties. The presiding officer appoints a three-member disciplinary panel consisting of advisory board members to determine whether a certificate or permit should be temporarily suspended.

## **Texas Bullion Depository**

(Comptroller of Public Accounts)

**Legislation:** House Bill 483, Sections 1-10 and 12 **Effective:** June 19, 2015

**Function:** Serves as the custodian, guardian, and administrator of certain bullion and specie that may be transferred to or otherwise acquired by the state or an agency, political subdivision, or another instrumentality of the state

**Composition (unspecified number of members):** The depository is administered as a division of the office of the comptroller of public accounts and under the direction and supervision of a bullion depository administrator appointed by the comptroller with the advice and consent of the governor, the lieutenant governor, and the senate. The administrator may appoint, subject to comptroller approval, a deputy administrator or other subordinate officer as necessary and appropriate to the efficient administration of the depository.

# **Texas Commission on Next Generation Assessments and Accountability** (Texas Education Agency)

**Legislation:** House Bill 2804, Section 8 **Effective:** June 19, 2015

#### **Function:**

- Develops and makes recommendations for new systems of student assessment and public school accountability
- Prepares and delivers a report to the governor and the legislature, not later than September 1, 2016, that recommends statutory changes to improve systems of student assessment and public school accountability

33 New Entities

#### Composition (15 members total):

- 4 members appointed by the governor
- 3 members appointed by the lieutenant governor
- 3 members appointed by the speaker of the house
- The chair of the Senate Committee on Education, or a representative designated by the chair
- The chair of the Senate Committee on Higher Education, or a representative designated by the chair
- The chair of the House Committee on Public Education, or a representative designated by the chair
- The chair of the House Committee on Higher Education, or a representative designated by the chair
- 1 member of the State Board of Education, as designated by the chair of that board

The governor designates the presiding officer of the commission. In making appointments, the governor, the lieutenant governor, and the speaker of the house must coordinate to ensure that the commission includes at least one of each of the following representatives:

- An educator in a school district that is a participant in the Texas High Performance Schools Consortium
- A member of the business community
- A member of the civic community
- A leader in student assessment development and use
- A leader in research concerning student assessment and education outcomes

# **Texas Forensic Science Commission Advisory Committee**

(Texas Forensic Science Commission)

**Legislation:** Senate Bill 1287, Section 4

Function: Advises the Texas Forensic Science Commission and makes recommendations on

Effective: September 1, 2015

matters related to the licensing of forensic analysts

#### Composition (9 members total):

- 1 prosecuting attorney recommended by the Texas District and County Attorneys Association
- 1 defense attorney recommended by the Texas Criminal Defense Lawyers Association
- 7 members who are forensic scientists, crime laboratory directors, or crime laboratory quality managers, selected by the commission from a list of 20 names submitted by the Texas Association of Crime Laboratory Directors and that must include representation from municipal, county, state, and private crime laboratories that are accredited by the commission

Members serve staggered two-year terms, with the terms of four or five members, as appropriate, expiring on August 31 of each year. A member may not serve more than two consecutive terms. The advisory committee elects a presiding officer from among its members to serve a one-year term. A member may serve more than one term as presiding officer.

## **Texas Good Neighbor Committee**

**Legislation:** Senate Bill 1389, Section 1 **Effective:** September 1, 2015

#### **Function:**

- Advises the border commerce coordinator on key trade, security, and transportationrelated issues important to the municipalities appointed to the committee
- Holds quarterly meetings with mayors from Mexico to increase cooperation, communication, and the flow of information and to identify problems and recommend solutions
- Seeks assistance and input from private sector stakeholders involved in commerce to identify issues to address
- Provides recommendations to assist the coordinator in carrying out the coordinator's statutory duties

**Composition (unspecified number of members):** The border commerce coordinator appoints the membership, consisting of mayors from every municipality located in Texas along the Texas-Mexico border that has an adjoining sister city in Mexico.

## **Texas Health Improvement Network**

(The University of Texas System)

**Legislation:** House Bill 3781, Sections 1 and 2 **Effective:** June 19, 2015

#### **Function:**

- Addresses urgent health care challenges and improves the health care system in Texas and the nation
- Develops health care initiatives, policies, and best practices based on population health research
- Functions as an incubator and evaluator of health improvement practices
- Supports local communities in Texas by offering leadership training, data analytics, community health assessments, and grant writing support
- Reports the results of the network's efforts, findings, and activities to the legislature, state and federal partners, and other interested entities

**Composition (unspecified number of members):** Consists of experts in the following fields:

- General public health and other medical fields
- Mental health
- Nursing
- Pharmacy
- Social work
- Health economics
- Health policy and law
- Epidemiology
- Biostatistics
- Health informatics
- Health services research
- Engineering
- Computer science

## **Texas Health Improvement Network Advisory Council**

**Legislation:** House Bill 3781, Section 1 **Effective:** June 19, 2015

**Function:** Advises the Texas Health Improvement Network on the health care needs of Texas **Composition (unspecified number of members):** The advisory council is composed of:

- Members who are appointed by an executive officer of The University of Texas System and nominated by participants in the network and who are state and national leaders in population health, experts in traditional public health and medical fields, and leaders in the fields of behavioral health, business, insurance, philanthropy, education, and health law and policy
- Representatives from the Department of State Health Services and the Health and Human Services Commission, selected by the executive head of the applicable agency

Members of the advisory council serve staggered three-year terms, with the terms of one-third of the members expiring on January 1 of each year. The executive officer of the UT System who appoints members to the advisory council must appoint a presiding officer from among the members to serve a one-year term.

## **Timothy Cole Exoneration Review Commission**

(Texas Judicial Council)

**Legislation:** House Bill 48, Section 1 **Effective:** June 1, 2015

#### **Function:**

 May review and examine all cases in Texas in which an innocent defendant was convicted and then, on or after January 1, 2010, was exonerated to:

- identify the causes of wrongful convictions and suggest ways to prevent future wrongful convictions and improve the reliability and fairness of the criminal justice system
- ascertain errors and defects in the laws, evidence, and procedures applied or omitted in the defendant's case
- consider suggestions to correct the identified errors and defects through legislation or procedural changes
- identify procedures, programs, and educational or training opportunities designed to eliminate or minimize the identified causes of wrongful convictions

37 New Entities

- collect and evaluate data and information from an actual innocence exoneration reported to the commission by a state-funded innocence project, for inclusion in the commission's report
- identify any patterns in errors or defects in the criminal justice system in Texas that impact the pretrial, trial, appellate, or habeas review process
- consider and suggest legislative, training, or procedural changes to correct the patterns, errors, and defects in the criminal justice system that are identified through the work of the commission
- Reviews and updates the research, reports, and recommendations of the Timothy Cole advisory panel
- Compiles and issues a detailed report on its findings and recommendations and, not later than December 1, 2016, submits the report to the governor, the lieutenant governor, the speaker of the house, the legislature, and the Texas Judicial Council

#### Composition (11 members total):

- 1 member appointed by the governor
- The chair of the Senate Committee on Criminal Justice
- The chair of the Senate Committee on State Affairs
- The chair of the House Committee on Criminal Jurisprudence
- The chair of the House Committee on Judiciary and Civil Jurisprudence
- 1 member appointed by the chair of the Texas Judicial Council
- The presiding officer of the Texas Commission on Law Enforcement (TCOLE), or a member or employee of TCOLE appointed by the presiding officer
- The presiding officer of the Texas Indigent Defense Commission, or a member or employee of that commission appointed by the presiding officer
- The presiding officer of the Texas Forensic Science Commission, or a member or employee of that commission who has significant experience in the field of forensic science appointed by the presiding officer
- The president of the Texas Criminal Defense Lawyers Association, or the president's designee
- The chairman of the board of the Texas District and County Attorneys Association, or the chairman's designee

The following persons serve as advisory members to the commission:

• The director of the Texas Center for Actual Innocence at the University of Texas School of Law

- The director of the Texas Innocence Network at the University of Houston Law Center
- The executive director of the Innocence Project of Texas
- The executive director of the Innocence Project at Thurgood Marshall School of Law

Members of the commission serve until the commission is dissolved. The presiding officer is elected by the commission members and may appoint committees from the membership as needed to organize the commission or to perform the duties of the commission.

**Expiration Date:** The commission is dissolved on the earlier of the date the commission submits its report or December 1, 2016.

## **Uniform Pre-Nursing Curriculum Advisory Committee**

**Legislation:** House Bill 3078, Sections 1 and 2 **Effective:** June 18, 2015

#### **Function:**

- Develops and makes recommendations regarding the creation of a uniform pre-nursing curriculum for undergraduate professional nursing programs offered by institutions of higher education
- Assesses, as of September 1, 2016, the prerequisite courses that are required for each undergraduate professional nursing program in Texas and the ability of a student to use course credit earned at one institution of higher education to qualify for consideration for admission to an undergraduate professional nursing program offered by another institution of higher education
- Prepares and, not later than December 1, 2016, submits to the legislature and to each standing legislative committee with primary jurisdiction over higher education a report containing the committee's findings

#### Composition (at least 16 members):

- The commissioner of higher education or the commissioner's designee
- The executive director of the Texas Board of Nursing or the executive director's designee
- 2 representatives of professional nursing associations, appointed by the board
- 1 representative from the undergraduate professional nursing programs offered by at least 12 institutions of higher education, appointed by the board with at least 3 representatives from junior colleges, at least 3 representatives from general academic teaching institutions, and at least 3 representatives from health science centers

**Expiration Date:** January 1, 2017

## **Wine Industry Development Advisory Committee**

(Department of Agriculture)

**Legislation:** <u>Senate Bill 880</u>, Sections 1-3 and 7. The new entity is established in Section 50B.002, Agriculture Code, which revises language relating to the Wine Industry Development and Marketing Advisory Committee, which was abolished by Senate Bill 880.

Effective: September 1, 2015

#### **Function:**

- Develops a long-term vision and marketable identity for the Texas wine industry that takes into consideration future industry development, funding, research, educational programming, risk management, and marketing
- Assists the commissioner of agriculture in establishing and implementing the Texas
   Wine Marketing Assistance Program
- Assists and advises the commissioner in determining the best and most productive and efficient expenditures of the wine industry development fund
- Not later than September 1 of each year, provides the commissioner with a written report containing a summary of the committee's discussions, conclusions, and recommendations from the fiscal year preceding that date; a proposed schedule and plan of action for the fiscal year beginning on that date designed to implement and further the objectives of the advisory committee and the assistance program in the Department of Agriculture; a proposed budget and prioritized spending plan for expenditures of the wine industry development fund; and other information requested by the commissioner or determined by a majority of the committee to be appropriate for inclusion in the report

**Composition (unspecified number of members):** The committee consists of members appointed by the commissioner to represent a diverse cross-section of the wine industry, including representatives of the following:

- Grape growers representing various regions of Texas
- Wineries representing a variety of small, medium, and large formats from the various regions of Texas
- Researchers or educators specializing in viticulture or enology
- Consumers who are not affiliated with the alcoholic beverage industry
- The Department of Agriculture
- The Texas Alcoholic Beverage Commission (TABC)

A consumer who is not affiliated with the alcoholic beverage industry or a TABC representative appointed to the board is a nonvoting member. The commissioner may

appoint a person who previously served on the abolished Wine Industry Development and Marketing Advisory Committee to the Wine Industry Development Advisory Committee.

## **Women's Health Advisory Committee**

(Health and Human Services Commission)

**Legislation:** Senate Bill 200, Section 2.12



Composition (unspecified number of members): The executive commissioner of the Health and Human Services Commission appoints the committee members, the majority of whom must be health care providers who are participating in women's health programs of various sizes, be located in separate geographic areas of Texas, and have experience in operating women's health programs. The executive commissioner may also appoint a member who represents the women's health industry and is knowledgeable on the best practices for women's health programs.

**Legislation:** House Bill 3315, Section 1 **Effective:** September 1, 2015

**Function (revised):** Revised to broaden the scope of the advisory board. The advisory board advises the Texas Department of Licensing and Regulation concerning general issues relating to combative sports events and contestants.

**Composition (unchanged):** The Texas Commission of Licensing and Regulation, upon appointment of the advisory board, establishes the number of board members, the qualifications for appointment to the board, and the purpose and duties of the board.

# **Drug Utilization Review Board**

(Health and Human Services Commission)

Previous Name: Texas Medicaid Drug Utilization Review Board

Legislation: Senate Bill 200, Section 3.08; Senate Bill 277, Section 2.08

Effective: January 1, 2016

**Function (revised):** Revised to include the development of certain recommendations made to the Health and Human Services Commission (HHSC), including recommendations for preferred

drug lists previously developed by the Pharmaceutical and Therapeutics Committee, which was abolished by S.B. 200, and to include the review of drug utilization across Medicaid

**Composition (revised—at least 20 members):** Revised to include at least 20 members determined by the executive commissioner of HHSC

### Office of Capital and Forensic Writs

(Court of Criminal Appeals)

**Previous Name:** Office of Capital Writs

**Legislation:** Senate Bill 1743, Sections 1-10, 12-19, 20, and 21

**Effective:** September 1, 2015

**Function (revised):** Revised to expand the actions or proceedings in which the office is authorized to represent a defendant in state court and to authorize the office to consult with law school clinics with applicable knowledge and experience and with other experts as necessary to investigate the facts of a case

**Composition (revised—unspecified number of members):** Revised to include experts among the persons the director of the office must employ to perform the duties of the office

Note: Senate Bill 1743 also renames the capital writs committee as the capital and forensic writs committee but does not revise the committee's composition or sole function of recommending a director for the office of capital and forensic writs, when a vacancy exists, to the court of criminal appeals.

#### **Southwestern States Water Commission**

Previous Name: Multi-State Water Resources Planning Commission

**Legislation:** House Bill 163, Sections 1-11 and 13 **Effective:** September 1, 2015

**Function (revised):** Revised to function as an advisory commission to the governor and the legislature and changes previously required duties of the commission to authorized duties of the commission

**Composition (revised—3 members total):** Revised to decrease membership from seven to three commissioners, consisting of the following:

- The governor, or the governor's designee, who serves as the chairman of the commission
- 1 member of the standing committee of the house that has jurisdiction over natural resources, appointed by the governor
- 1 member of the standing committee of the senate that has jurisdiction over water issues, appointed by the governor

The two appointed commissioners serve staggered terms of four years with the term of one appointed commissioner expiring on February 1 of each odd-numbered year. The governor or the governor's designee must act as the official representative of Texas on the commission and must exercise all powers and duties of the state as a member of the commission.




